The application for renewal of accreditation must establish that the representative remains eligible for accreditation and has continued to receive formal training in immigration law and procedure (annually with supporting documentation) for the three-year period of the representative's accreditation. 8 C.F.R. § 1292.16(c)(2). Furthermore, as practitioners, whether before DHS or EOIR, accredited representatives are subject to and responsible for the Professional Conduct Rules found at 8 C.F.R. §§ 292.3 et seq. and 1003.102 et seq. In addition, as a condition of practice as a fully Accredited Representative before the Immigration Courts and the BIA, the individual must register electronically and in person with EOIR. The application for renewal of accreditation must establish that the representative remains eligible for accreditation and has continued to receive formal training in immigration law and procedure (annually with supporting documentation) for the three-year period of the representative's accreditation. 8 C.F.R. § 1292.16(c)(2).
